The National Science Foundation BioXFEL Science and Technology Center watched bio molecular machines at work using x-ray lasers, to better understand how life works at the molecular levels, to understand how these molecular machines support life on earth, to invent, discover, develop, and provide new tools and training for the wider scientific community.

IMCA-CAT provided an outstanding support environment for macro-molecular crystallography by developing and operating an efficient, reliable, high-throughput facility at which both confidential and proprietary experiments can be readily and easily accommodated.

Families of orthologous, paralogous, and mutated TMPS were targeted and multiple variants were carried through the early stages of purification and characterization so as to maximize the chances of advancing the most tractable members of a given target was produced at an intermediate scale to allow characterization using an existing high-throughput screen for detergent compatibility, biophysical and biomedical characterization and small scale exploratory crystallization trials. The project also seeks to develop improved technologies for increasing levels of expression of functional TMPS in yeast, new approaches for specific fluorescent labeling of unpurified proteins, and the development of improved methods for biophysical characterization and screening of protein detergent complexes.

The Board of Directors has interpreted New York State Prudent Management of Institutional Funds Act (NYPMIFA) as requiring the preservation of the fair value of the original gift as of the gift date of the donor-restricted endowment funds absent explicit donor instructions to the contrary. Any remaining portion of the donor-restricted endowment fund that is not classified in permanently restricted net assets is classified as temporarily restricted net assets until those amounts are appropriated for expenditure by the Board of Directors in a manner consistent with the standard prudence prescribed by NYPMIFA. The purpose of these endowment funds is to provide investment income to support the Institution's mission.

Schedule D, Part X, Line 2 - The Institute is exempt from taxation under Section 501(C)(3) of the Internal Revenue Code and, accordingly, no provision for income taxes has been reflected in the accompanying financial statements.
